Four Wichita State University graduate sport management students recently traveled to Orlando, Fla., to compete in the 2013 Case Cup competition that annually kicks off one of the largest conferences in the industry at the National Sports Forum.

Captain Travis Richardson, who is a graduate research assistant for the Department of Sport Management joined Julica Bonsall, also a graduate research assistant in the Department of Sport Management, Boomer Jenkins, a graduate assistant in the College of Education Dean's Office, and Sarah Willey, a graduate assistant for the Shocker Volleyball team to form the team selected by an application process.

Only eight Sport Management programs are invited to participate in the competition, pitting the best programs in the country against each other in a fast-paced competition that lasts just 24 hours. Teams are given their cases at a designated time on a Saturday morning, and have just 24 hours to research and develop a 20-minute presentation for a panel of judges that includes a mixture of sport practitioners and academic scholars. The judges are allowed a 10-minute Q&A period with the teams following their presentation, and hold nothing back in questioning the validity of the groups' plans.

"This is a prestigious competition among the best graduate sport management programs in the country," said Mike Ross, an instructor in the Department of Sport Management and faculty advisor to the team. "Our team represented very well and were great ambassadors for our program. This competition is strenuous for several reasons, but always brings the best out of each of its participants."

The eight schools are divided into two flights of four, with four judges in each flight, and presentations run all morning on Sunday until the judges pick a winner of each flight to advance to the finals. Finalists then present in front of the entire panel of eight judges and an audience that approaches 80 people.

This year's case dealt with Chobani yogurt's sponsorship with the U.S. Olympic Committee, and ideas to help leverage the sponsorship and provide more activation for the growing company in non-Olympic years. The University of Oregon took home top honors this year thanks to a presentation that included a mobile game for the company. Chobani officials were on site to answer questions the students may have had, and assist with the competition.

"The case this year was both challenging and unique for us as a group," Richardson said. "We had to create a comprehensive sponsorship plan that was effective while also conforming to the organizational values of Chobani."

This year's team earned high praise from the judges for their campaign "How do you Chobani?" which included a strong social media platform combined with targeted media advertising toward men and children. The plan also included a broad nationwide sampling campaign, a founding principle of the yogurt manufacturer.

Wichita State has been invited to the National Sports Forum Case Cup competition each of the last two years. The WSU Sport Management
