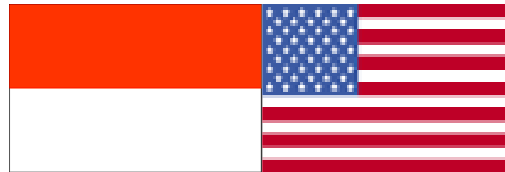

“DOING BUSINESS WITH INDONESIA”

Keynote Speaker: Honorable Andriana Supandy, Consul General

Indonesia is the biggest country in ASEAN and 15th GDP (PPP) in the world with US\$ 1.3 trillion. Economy grew at 6-6.5% during past 5 years. Indonesia is also blessed with rich natural resources - crude oil, natural gas, tin, copper, and gold. Its key imports include machinery and equipment, chemicals, fuels, and foodstuffs. Major exports include oil and gas, electrical appliances, plywood, rubber and textiles. With 253.6 million people spread across more than 17,500 islands, the Indonesian archipelago has been a pivotal trading hub since 7th century; and 3rd largest democracy. A growing middle class income projection is \$170 million (2015). The WSJ predicts US-Indonesian trade could grow to \$60 billion per year over the next five years from around \$30 billion today. Indonesia is a G20 BEM. Total foreign direct investment in 2014 is expected to grow 15 percent to about 456 trillion Rupiah(\$38 billion) after rising
