| Gen Ed. Revision Comm.: FYI | Message from chair of Gen. Ed. Revision Committee: "Charge given by the Senate": Examine the necessity to revise, maintain, or replace the General Education Program as currently practiced. The Committee has decided to Revise (by reduction [in credit hours] and modification). - Q is there any sense of the number of credit reduction and in what areas? A: No exact numbers yet, likely reduce by 6 to 12 credit hours. Q: Who should be contacted with questions? A: Start with the representative from your college and then go to Bill Hendry. |  |

| Faculty Affairs | First Reading: HR Policies-Discussion of Recommendations - have reviewed and written the perceived pros and cons of the draft policies. With respect to attendance policy - felt that distinctions should be made for faculty, since office hours and off-campus responsibilities can vary. Q: Will we vote on this? A: Yes, we will vote to approve the comments from the committee that will then go back to HR. Q: Are we facing legislative pressure with respect to working hours? A: No evidence of this. |  |


|  | With respect to furloughs - How do we handle furloughs that impact only <br> certain week days when you may or may not be teaching? Q: Are there <br> essential and non-essential employees? A: Yes, departments will <br> identify. Concerns were raised about exempting faculty since this creates <br> a further hierarchy between faculty and staff. Was mentioned that <br> employees may be able to choose the days they are furloughed, to <br> accommodate critical work days. | With respect to volunteer review - deals with unpaid university <br> volunteers. Q: What was motivation? A: No specific cases but many <br> cases where someone wants to volunteer - examples - volunteers to teach <br> class, retired faculty who continue to work. Another example was given <br> in which volunteers with specific expertise may offer to speak at a clinic, <br> for instance in health professions. Concerns raised over language <br> regarding "familial relation in supervisors". Q: What was motivation? <br> A: not sure. Concerns raised about the many "volunteer" activities with <br> high school students, and student group volunteers. |

| KBOR Triggered Programs | Update from Provost Muma - KBOR requires 25 majors and ten <br> graduates on five year average for underggaduate degrees. For masters <br> degrees, 20 majors and 5 graduates on five year average are required, and <br> for PhD 5 majors and two degrees are required. Looked at example of the <br> "liberal studies" degree as one that might be eliminated or combined with <br> BGS. Degree production is more important than enrollment. Rick will <br> present at the December meeting and will need to have feedback from the <br> Deans on the individual triggered programs. |  |
