Shocker Rowing Equipment Rental Agreement

For consideration indicated below, Wichita State Rowing Team, an incorporated not for profit entity having an official address at Box 126 of the Heskett Center on the campus of Wichita State University, Wichita, Kansas 67260 (hereinafter WSRT), agrees to rent to _____, (hereinafter Renter), the following rowing equipment: Rowing shells: Dirigo, Resolute, and/or Pocock, Concept II Sweep and/or Sculling Oars, and Slings.

Said equipment to be rented under the following conditions:

- 1. No rental charge for the use of the equipment listed above during the Plains Regional Regatta with a signed copy of the Rental Agreement.
2. Equipment will be made available to Renter in Wichita, Kansas on Sunday, May 1, 2022 and will be returned to WSRT at the same location that day. Equipment will be returned cleaned and free of any debris, tape residue or alterations except for rigging adjustments.
3. Renter will check all equipment for damage upon pick-up, and indicate any damage upon pick-up to WSRT. WSRT will check for damage on return and indicate any new damage at that time to Renter.
4. Renter accepts full responsibility, and agrees to pay WSRT, for any and all damages to WSRT equipment occurring during the term when the Renter has the equipment, whether or not caused by Renter or its oarsmen or agents. Cost of damaged parts shall be current replacement cost established by the manufacturer of the equipment. Renter agrees to pay repair bills from The Rowing Repair Center for any damages, as well as cost of transportation of equipment for repairs.
5. Renter acknowledges that rowing is an activity which inherently involves substantial risks and dangers. Renter will ascertain that anyone who uses WSRT equipment during the period of this rental agreement has been instructed in water safety and is a capable swimmer. Renter hereby releases and holds harmless WSRT, as well as its officers, directors, employees, agents, the University and the state of Kansas from any and all liability which may arise from Renter's use of WSRT equipment, and agrees to indemnify WSRT against any and all claims.
