#### Primary Course Responsibilities:

Below are descriptions of each course I taught for the AGE program for the 2014-2020 academic term.

- a. *Title*: <u>AGE 100 Introduction to Aging Studies (Gerontology)</u>. *Course Description*: A multidisciplinary overview of the field of aging, with attention to cultural, social, psychological, biological, and economic factors which influence the circumstances of the older adult.
- b. *Title*: <u>AGE404 Psychology of Aging</u>. *Course Description*: This course provides examination of the issues surrounding the adult aging process. Includes personality and intellectual change, mental health of the older adult, and the psychological issues of extending human life. Emphasizes the strengths of the older adult and prevention of psychological problems of the older adult.
- c. Title: <u>AGE515 Women and Aging</u>. Course Description: This course introduces students to issues in aging that are unique to women, to women's diverse developmental patterns, and to research methods appropriate for studying aging women and their life experiences. Topics include physical change, role transitions, and adaptation from a lifespan perspective. Cross-listed as WOM T580.
- d. *Title*: <u>AGE 525/825 Death and Dying</u>. *Course Description*: This course offers a broad overview of the psychological aspects of death and dying in our society. Topics include attitudes toward and preparation for death; the understanding of and care for terminally ill patients; funeral rituals; burial, mourning and grief practices; suicide and euthanasia. The class involves experiential learning activities such as personal preparation for death and field trips such as visiting a funeral home. These learning activities are designed to help the student be better equipped to help those who must make such preparations for themselves or loved ones.
- e. *Title*: AGE 422 Public Health and Aging. *Course Description*: This course explores the study of aging and the range of health issues that older persons, their families, their providers and society will face in the next decade. The materials and course instruction present an overview on aging from different perspectives: demography, biology, epidemiology of disease, physical and mental health disorders, functional capacity and disability, social aspects of aging and ethical issues in the care of older individuals.
- f. *Title*: AGE 717 Health Communication and Aging. *Course Description*: There are many facets of communication and aging. This course is a multidisciplinary, empirically-based consideration of emotions, behaviors, beliefs, and attitudes related to aging and the process of communicating with older adults. Topics include: approached to communication and aging, current evidence about communication and the aging population, interpersonal and intergenerational communication, mass communication and aging, health and healthcare interactions (patient-physician communication, etc.), older adults and technology, and cultural change. Students will develop applied skills and critical thinking. Applications to Public Health will be explored throughout the course.
- g. *Title*: <u>AGE 720 Independent Readings.</u> *Course Description*: This course provides an overview of examination of the methods of using published literature and population data as approaches to understanding aging and the aged. Students gain practical experience in these methods through individual readings.
- h. *Title*: <u>AGE 798 Interprofessional Perspectives on Aging.</u> *Course Description*: This course requires students to identify the myths and realities of aging, examine societal implications of aging trends in the United States and internationally, enhance analytical skills for the evaluation of published age-related research, and apply knowledge from profession and personal experiences.
- i. *Title*: <u>AGE 804 Programs & Policies.</u> *Course Description*: This online course requires students to analyze and evaluate policies and programs related to aging and old age. Emphasizes the importance of social values and historical context for understanding current policies, programs, and practices. Prerequisite: AGE 798, 12 hours of gerontology, or instructor's consent.

- j. Title: <u>AGE 801 Field Research and Aging</u>. Course Description: This course provides an examination of the methods of participant observation and interview as approaches to understanding aging and the aged. Students gain practical experience in these methods through individual fieldwork projects. Prerequisite: AGE 798, 12 hours of aging studies credit, or instructor's consent.
- k. Title: AGE 813 Sociology of Aging. Course Description: This course provides an overview of the significant sociological perspectives, social issues, and social science research pertaining to the phenomenon of aging in society. The course will examine the major theories of social aging, analyze the changing demographic trends and the political economy issues facing aging societies; describe how the broader societal context affects the nature of family relationships, community involvement, and the experiences of retirement and widowhood among the older adult; and examine the current issues in health and social service delivery for the care of the older adult. The course examines a substantive field which has a major social policy as well as personal significance in contemporary life.
- 1. *Title*: AGE 822 Advanced Perspectives of Public Health and Aging. *Course Description*: This course explores the study of aging and the range of health issues that older persons, their families, their providers and society will face in the next decade. The materials and course instruction present an overview on aging from different perspectives: demography, biology, epidemiology of disease, physical and mental health disorders, functional capacity and disability, social aspects of aging and ethical issues in the care of older individuals.
- m. *Title*: <u>AGE 895 Thesis Research.</u> *Course Description*: This course includes individual guidance in the development of a specific research problem. Potential thesis topics should be formulated by the student and discussed with their thesis adviser. May be repeated for a maximum of 6 hours credit. Prerequisite: completion of, or current enrollment in, all academic coursework for the master's degree.
- n. *Title*: **PHS 410 Health Communication.** *Course Description*: This course is designed to help student discover the vital role that health communication plays and the factors influencing health communication in various settings. Principles of health communication will be explored on many levels including: interpersonal patient, family and provider conversations, the role of technology related to health communication, health organization communication, communicating health data and statistics, risk communication, health promotion messaging and the role of media. The course explores the theory, research, and skills associated with communicating in these various contexts.
