



COVID-19 – Onsite Biometric Screening Protocol

There is no greater value than the health and well-being of our clients and healthcare providers, we want to assure you that US Wellness is taking all necessary precautions to protect your employee's safety and that of our healthcare providers. As we return to services, US Wellness commits to following the recommended guidelines issued by US Centers of Disease Control (CDC) and local health departments. To this end, in

- **Cleaning and Disinfecting:**
 - US Wellness abides by the US Centers for Disease Control and Prevention (CDC) and The US Occupational Safety and Health Administration (OSHA) current recommended guidelines for disinfecting work area and work surfaces, including but not limited to: disinfect screening area including, screening station tables and chairs, frequently touched and high traffic surfaces, and screening equipment prior to and in between each use using known disinfectant products
 - US Wellness will provide the necessary disinfecting materials for use during event
- **Social Distancing:**
 - Participants may not arrive earlier than five minutes before their designated screening appointment
 - Participants and other non-participants accessing the screening area must maintain social distancing guidelines of no less than 6 ft. from each other
 - No more than 10 individuals may access the screening space at any given time
 - Participant will sit within 2.5 feet of screener. Participant may wear a mask during screening
 - Screening participants are asked to wear a mask
- **Screener PPE:**
 - US Wellness will track and monitor symptom and temperature of screeners prior to arriving at worksite. Screener reporting related symptoms and/or high temp will not be allowed to access client worksite.
 - US Wellness will require all staff to record their temperature and symptoms using a digital symptom tracker prior to arriving at the screening event.
 - All screening staff will wear the following Personal Protective Equipment (PPE): mask, safety eye covering, medical gloves.
 - Screener will dispose of and replace gloves after each initial disinfecting and after each participant.
- **Registration Staff:** US Wellness will temporarily cease to provide registration staff. All paperwork will be provided at the screening station to avoid the need for clipboards, paperwork and pens being passed around from participant to participant.
- **Screening Station:**
 - Screening area will be free from materials other than what is needed for current screening of expected participants
 - Equipment will be disinfected between each participant appointment, including blood pressure cuff, cholesterol analyzer, screening table, participant chair
 - Disposable sanitization sheets used for weight and height measurements
- **WORKSITE REQUIREMENTS:** Updated screening protocol will include assistance from the client to assure a safe environment. Prior to the screening, clients will be asked to:
 - Provide visible 6' spacing measures (with tape or signage)
 - Instruct screening participants to bring their own pens to registration
 - Encourage screening participants to wear masks to the screening
 - Take necessary measures to assure employees are asymptomatic prior to participating in the screening
