## Participation Agreement Contract for IT Hardware and Related Supplies and Services # 17010729 between CDW Government LLC and Wichita State University

Milwaukee Ave, Vernon Hills, IL 60061 ("Seller" or "Contractor", indistinctively) and Wichita State University ("Participating User") a political subdivision or participating user from the Contract for IT Hardware and Related Supplies and Services #17010729 executed between Seller and the University of Kansas ("University") September 21, 2018 (the "Master Agreement").

**WHEREAS**, Participating User desires to procure IT Hardware and Related Supplies and Services from Contractor pursuant to the Master Agreement; and

WHEREAS, Seller is an authorized seller of IT Hardware and Related Supplies and Services to Participating Entities pursuant to the terms and conditions of the Master Agreement by and between Seller and the University; and

**NOW THEREFORE**, for good and valuable consideration, the sufficiency of which is hereby acknowledged the parties agree as follows:

- 1. The terms and conditions of this Participation Agreement shall incorporate the Master Agreement, including Exhibit A which is attached hereto for convenience, except to the extent expressly provided herein. Each capitalized term used herein and not otherwise defined shall have the same meaning attributed to it in the Master Agreement.
- 2. The following terms and conditions are expressly modified for this Agreement:
  - <u>a.</u> <u>Term:</u> The term of this Participation Agreement shall begin as of the Effective Date and shall be concurrent with the term of the Master Agreement, unless terminated as provided herein.
  - **<u>b.</u>** The following sections of the Master Agreement do not apply to this Participation Agreement:
  - i. Rebate section in Specifications in the Contract Award,
  - ii. Firm Fixed product specified in Contractor's written proposal submitted in response to this solicitation as finalized, Exhibit B in the Master Agreement, and
  - iii. Cisco and HPE/Aruba MSRP discount pricing in Contractor's written proposal submitted in response to this solicitation as finalized, Exhibit B in the Master Agreement,

Except as modified herein, all other terms and conditions of the Master Agreement shall remain in full force and effect. This Agreement in no way modifies or alters the Master Agreement for the contracting parties identified therein.
